The 1st International Congress for All Mediations – Mediations 2020 will take place in Angers – France - from 5th to 7th February 2020.

MEDIATION: AN INCREASINGLY USED METHOD

Nowadays, mediation has become an essential process. Well-structured and working through volunteering and cooperation, it is a method of prevention and amicable resolution of conflicts. It is based on the responsibility and autonomy of the participants. Increasingly used in our world in transition, mediation is now more than a state of mind, **but a society project putting human being at the heart of the prevention and the conflict resolution.**

For the first time, international experts of Mediation will gather in Angers: mediators from liberal professions, institutional mediators, volunteer mediators, teachers-researchers, legal experts, sociologists, journalists, CEOs, companies and organizations key players... The purpose: To build the mediation's future by sharing good practices; comparing institutional, sectoral and legal positioning in different realms of mediation and by releasing abstracts and scientific studies. Mediations 2020 falls within an approach of initial and continue education.

THE CONFERENCE: A UNIQUE AND DIVERSIFIED PLACE OF EXCHANGES

Its unique multi-area approach will explore all application scopes of mediation: social, administrative, in companies, for consuming, in families, legal, conventional, in neighbourhood, societal, institutional and regional, but also the prevention and resolution of international conflicts.

Among the topics of Mediations 2020:

- Artificial Intelligence: opponent or ally of all cultures of mediations;
- Restorative mediation;
- Independence, impartiality and neutrality of mediators : legal, procedural, behavioural and ethical assumptions;
- Citizen mediation and relation between mediation and law access;
- Conflict in all its forms;
- Resolution of international conflicts – a peace factor

Mediations 2020 is organized by the Association of Mediators from regional authorities (AMCT) and Destination Angers. The co-organizers are the MEDIATION 21 group - which gathers nearly 30 French associations linked with mediation -, the National Network for Legal Access and Mediation (RENADEM), the Federation of Mediation Centres from Western France (FCMGO), the Catalan Network of territorial mediators (Forum SD) and the Club of Public Services Mediators (CMSP).

Far from being composed of mere conferences, the Mediations 2020 conference is a place of exchanges, which will gather more than 300 prominent figures from the five continents. It will strengthen projects and the sharing of networks and experiences. The focus is on confrontation of ideas and points of views of international experts and influencers, company's leaders and decision-makers from public and private sectors. However, it will also offer citizens the opportunity to commit themselves by participating in conferences open to the public.
